PHASE II - THE DESIGN PHASE. THIS PHASE BEGAN IN NOVEMBER 2016 AS THE FOUNDATION ENTERED INTO A CONTRACT WITH PRD GROUP LLC FOR PROFESSIONAL DESIGN SERVICES. THE LUMP CONTRACT SUM IS \$1,625,000 WITH
